Booth space will be reserved on a first registered, first served basis. No booth will be reserved until payment and signed Vendor Participant Form is received.

- If you are serving food or samples of food, you must contact Deidre @ the City of Longview Health Dept and complete their permit application by September 1, 2026. Their contact number is 903-237-1285.
- Please provide a copy of the event permit to ETAA by September 12, 2026. Those without required permits will not be permitted to participate in the event;
- Vendor will provide 10x10 tent, table w/décor, chairs, displays and signs and any other equipment necessary for vendor booth;
- Vendor will provide at least one staffer at the table throughout the event;
- Vendor will stay until the end of the event at 6PM;
- ETAA will provide assistance in unloading and setting up at designated times with volunteers and dollies;
